STUDENT PARKING RULES, REGULATIONS AND EXPECTATIONS

PLEASE READ THOROUGHLY AND CAREFULLY

St. Anne School is a self-park facility. Any vehicle that is parked at St. Anne School, on either campus, is parked at the owner's risk. The owner, alone, is responsible for parking and locking the vehicle. SAS is not responsible, nor does it assume liability for any damage caused by fire, theft, casualty or any other cause whatsoever with respect to any vehicle or its contents while parked at St. Anne School.

School authorities **have the right to check, search and enter vehicles** used to travel to or from school if there is reasonable suspicion of violation of school rules and regulations.

- The decal must be displayed in the top left corner of the rear window.
- The parking permit (sticker) provides parking **ONLY** for the student it is issued to. A parking permit **may not be shared or transferred to another student or sibling.**
- Only one decal will be issued per student and must be adhered to the registered vehicle.
- Vehicles without a decal, those illegally parked, or parked in an unauthorized area are subject to the following consequences: -
 1. **Warning**
 2. **Parking privileges revoked without refund of parking fee**
 3. **Car Towed at owner's expense**
- Forms of non-compliance with parking rules, regulations and expectations subject to disciplinary action and/or suspension of parking privileges, include but are not limited to:
 - Inappropriate conduct such as reckless driving, speeding, not yielding for parent drivers at the end of the day, etc.
 - Loitering in the parking lot before and after school
 - Excessive tardiness and trancies to school
 - Entering a vehicle unauthorized during the school day
 - Leaving the building unauthorized
 - Leaving campus unauthorized
- Students must observe unauthorized and restricted areas. These are posted or marked and include fire lanes, staff lots, visitor parking, reserved parking, and other marked areas. Vehicles parked in these areas are subject to immediate towing at the owner's expense.
- Replacement stickers will be provided at a cost of \$20.00.
